2021 NAPSA CONFERENCE EXHIBITOR & SPONSOR INFORMATION

NAPSA will host its 2021 virtual conference over several dates in September. This special event will be live-streamed from 1:00 p.m. to 6:00 p.m. EDT beginning on Tuesday, September 28, continuing on Thursday, September 28 and Tuesday, October 5, and concluding on Thursday, October 7. The exhibit hall will be open from 3:00 p.m. to 4:00 p.m. EDT each day and will be a live event where exhibitors can interact directly with conference participants. Companies can "staff their booth" from 2:00 to 6:00 p.m. EDT each conference day and also purchase main page banner ads for each day of the conference. Exhibit space and banner ads will feature clickable links to your website, opportunity to include company video link on exhibit booth page, and company printed materials that can be downloaded by conference participants.

The conference attracts practitioners from local, state, federal government agencies and from nonprofit organizations engaged in the delivery of pretrial services. Although some work directly within a pretrial services agency, many attendees work within probation or community corrections departments or within other justice agencies. Every year, the Conference attracts judges, law enforcement, policy makers, managers or administrators who are responsible for purchasing recommendations or decisions.
