

# **CANDIDATES FOR 2024 NAPSA ELECTIONS**

NAPSA will open its annual election on October 25, 2024. The election will be conducted electronically and will close November 15, 2024 at 11:59 p.m. EST.

In order to vote, you must be a member in good standing which means, at minimum, you must be a current member of NAPSA. Memberships sometimes lapse accidentally. Please check that your membership is active before voting, to ensure your vote will count and then:

## **VOTE HERE**

According to the Bylaws, to be elected as an Officer or Director, a candidate must be a member in good standing; prior experience on the Board of Directors is required for the Secretary and Treasurer positions, unless otherwise determined by majority vote of the Board. No Board member may serve more than 12 consecutive years on the Board.

## **Position Descriptions:**

## Secretary (Officer)

• Duties of the Secretary include, but are not limited to, ensuring Bylaws are up to date, providing oversight to Stakeholder Representatives and taking meeting notes when necessary. The Secretary serves a three-year term (to end December 31, 2027).

## **Treasurer (Officer)**

 Duties of the Treasurer include, but are not limited to, presenting the annual budget to the Board, reporting at the Annual Business meeting on the fiscal business of the Association and providing oversight of the fiscal responsibilities of the Board. The Treasurer's accounts and annual reports shall be subject to an annual audit. The designated bank and/or accounting services for the Association are subject to approval by the Board.

The Treasurer may serve as an authorized signatory on contracts with which the President or President Elect has a conflict of interest. The Treasurer serves a two-year term (to end December 31, 2026). The Treasurer can serve no more than two consecutive terms.

## Federal Director, Northwest Region Director and Southwest Region Director

- Regional Directors, including Federal Director, will have duties including, but not limited to, working directly with members in their region and providing regular updates to the Board regarding regional activity. Directors serve a three-year term (to end December 31, 2027).
- Location:

- Federal Director
  - Must be a practitioner within federal pretrial services
- Northwest Region Director
  - Must be a practitioner in one of the following jurisdictions: Alaska, Washington, Oregon, Idaho, Montana, Wyoming, North Dakota, or South Dakota
- Southwest Region Director
  - Must be a practitioner in one of the following jurisdictions: Hawaii, California, Nevada, Utah, Arizona, Colorado, or New Mexico, Guam
- Preferred candidate for each position will have a minimum of six years' experience in the field of Pretrial Services including leadership, program administration, or community activism and will be a champion of best practices. Must commit to an average of 10-15 hours a month to the Board; travel is required twice a year for Board meetings and participation in monthly Board calls is expected. Specific duties include, but are not limited to:
  - Work directly with members in assigned region;
  - Provide regular updates to members regarding regional activity;
  - Coordinate membership with affiliate states;
  - Regularly attends Board meetings and important related meetings;
  - Make serious commitment to participate actively in committee work;
  - Volunteer for and willingly accepts assignments and completes them thoroughly and on time;
  - Stay informed about committee matters, prepares themselves for meetings, and reviews and comments on minutes and reports;
  - Get to know other committee members and builds a collegial working relationship that contributes to consensus;
  - Is an active participant in the committee's annual evaluation and planning efforts; and
  - Participate in fund raising for the organization when/where applicable.

#### **Candidate Statements:**

Shawn LaGrega:

Shawn LaGrega is the Deputy Director of Maine Pretrial Services, Inc., which operates pretrial release and post-conviction programs throughout the State of Maine. Shawn began his career in the field of Pretrial in 1999 after working as a community educator for a domestic violence resource center and the Co-Director of a Batterers Intervention Program. Shawn currently serves as the Secretary for the National Association of Pretrial Services Agencies (NAPSA) and is the Chair of NAPSA's Accreditation Commission.

Shawn also serves on the Maine Commission on Domestic and Sexual Abuse and is a national trainer for the Ontario Domestic Assault Risk Assessment instrument (ODARA). He has presented nationally and internationally on topics including "Working with Men Who Batter", "Effective Supervision of DV Offenders in Pretrial Programs", "Assessing Risk in Domestic Violence Cases", "Addressing the needs of Incarcerated Women Who Are Victims/Survivors of IPV" and "Pretrial Agencies Role in a Coordinated Community Response to DV".

#### Kito Bess:

It is with great pleasure that I take this moment to announce my candidacy for the position of Secretary of NAPSA. For 3 years now, I have served as the Federal Director, assisting in providing quality education to my former constituents of the U.S. Probation & Pretrial Services Office. Prior to retirement, I served as Chief U.S. Probation Officer (Chief), in New Orleans, Louisiana, and Minneapolis, Minnesota, for nearly 14 years. In New Orleans, I was charged, in 2013, with the responsibility of consolidating our then, separate U.S. Probation and Pretrial Services Offices. This administrative task was successful, as Pretrial Services was able to maintain its identity, in the now consolidated office. Under this organizational structure, the Pretrial Services unit worked collaboratively with the Administrative Office of the U.S. Courts, Probation & Pretrial Services Division, to change the culture to an evidence-based agency. The results included an almost 20% reduction in unnecessary detention with no negative impact to outcomes, not to mention a favorable program review in FY14.

Also, after consolidation and with the outstanding partnership of the U.S. Attorney's Office, the Pretrial Services unit established a front-end reentry court program (i.e., Louisiana Eastern Alternative Program "LEAP"). LEAP offered a creative blend of treatment and sanction alternatives to effectively address defendant behavior, rehabilitation, and the safety of our communities. The goals of LEAP were to reduce recidivism and promote successful community reintegration while maintaining public safety. For successful completion, LEAP graduates were granted a dismissal of the charges, giving them renewed hope whereby avoiding the stigma of a felony conviction. Based on this and other efforts, the Administrative Office, in 2016, awarded the Eastern District of Louisiana (New Orleans), Pretrial Services unit, with the Daniel B. Ryan Award recognizing staff's outstanding performance in this area.

The work of identifying alternatives to detention continued throughout my tenure in the District of Minneapolis. Also as Chief, staff continued their outstanding work to offer provisional housing options, via the use of Second Chance Act funds, as an alternative to detention. As a

result, we were one of three districts under consideration for hosting the Federal Judicial Center's Annual Sentencing Institute, which was held in Detroit, Michigan, in October of 2023.

As a practitioner, I continue to believe in upholding the spirit of U.S. v. Salerno, in that liberty is the norm and detention is, indeed, the carefully limited exception. My work experience consists of both probation and pretrial services, having labored in various levels of government (i.e., County, State, and Federal). I tend to describe myself as a perennial learner, who is always willing to spread the wealth. As Chief, I hosted two major conferences focusing on pretrial services: 2018 Pretrial Services Conference (i.e., well over 200 in attendance), in Metairie, Louisiana; and 2021 Virtual Pretrial Services Conference, "Recipe for Success", sponsored via the District of Minnesota, in conjunction with other U.S. Pretrial Services Offices.

As Director of St. Louis County Justice Services (Director), I have continued learning and sharing pretrial related information for positive outcomes. We are working to revitalize our pretrial services program relying more on the research for process improvements. We continue to focus on increasing our staff and training to assist in their professional development as practitioners. We are working with stakeholders for the purpose of improving our services on behalf of the people of St. Louis County.

As Secretary of NAPSA, I see this labor of love as no different from my role as Chief or Director. It is an opportunity to engage with other outstanding practitioners; assist in the rebranding and rebuilding of our organization for greater outcomes amongst pretrial services agencies across the county; help with producing quality educational programming via our annual conferences; and continue to learn for my own professional development. Over the years, we have been blessed with an outstanding Secretary, who has contributed greatly to the Board. If selected as Secretary, NAPSA benefits by way of increasing its knowledge of professional expertise with a proven track record of accomplishments at the federal level; and I also benefit by way of having the opportunity to share NAPSA's knowledge within my present organization.

I hope to continue service as a Board Member with NAPSA.

#### Domingo Corona:

I would like to announce my candidate for the position of Treasurer for the Board of Directors of the National Association of Pretrial Services Agencies. I have been a pretrial services practitioner for over 26 years and have served in various leadership roles in pretrial services for 25 years. For the past 16 years, I have been in higher leadership roles serving 6 years as a manager and as the pretrial division's director for the past 10 years. In both roles, I have overseen assessment, supervision, and diversion functions, and I have also worked on courtwide strategic planning for over a decade. Agency-specific projects include multiple pretrial automation projects and more than one architectural planning effort directly involving pretrial's location pre- and post-booking our local jail. Furthermore, I have worked on multiple local risk instrument validation efforts, and I have overseen the court's move from a locally validated risk instrument tool to the Arnold Ventures PSA Court Tool (2016). As part of my work with the PSA implementation, I have developed a locally used Decision-Making Framework (2016), and recently I have led an effort to develop a new Release Conditions Matrix (2024). In addition to leadership within my court, I have served as participant in my county's justice coordinating council and on county-wide justice system planning workgroups, including participation in a core planning group for the county's involvement in the national MacArthur Foundation's Safety and Justice Challenge (SJC). As part of the SJC effort, I helped with the design of three new initiatives: reestablishment of a pre-booking release program, supportive services screening and supervision, and a sequential review program. Also, I have participated on multiple small workgroups for the MacArthur Foundation, one focused on pretrial risk management and one surrounding the effort to recruit, retain, and develop diverse leaders in the justice system. For the state of Arizona, I have been a voting member of the formal Arizona Pretrial Services Committee, and I have served on and have lead subcommittees. I was also asked to participate on an Arizona Task Force surrounding pretrial justice issues, and I also served on an Arizona Task Force which provided recommendations regarding presentence investigations. One of my proudest accomplishments is co-leading an informal network of state pretrial leaders, many of which work in rural jurisdictions. As for my national work, I was appointed to the National Institute of Corrections Pretrial Executives Network in 2015 and remain an active member. In 2017, I joined the National Association of Pretrial Services' Board of Directors as the Southwest Region Director and now serve as the Treasurer. A significant accomplishment in my time with NAPSA has been joining the writing team for the 2020 revision of the NAPSA Standards on Pretrial Release. In 2018, I was asked to participate in NRI's Mental Health/Criminal Justice Research Center Advisory Council, and in 2020 I joined the Advancing Pretrial Policy & amp; Research's Pretrial Practitioner Network as a member. In addition to these highlights, I have spent many years training pretrial justice professionals across my county, the state of Arizona, and across the country. I have led numerous training sessions at annual NAPSA National Training Conferences, including all Fundamentals Track sessions and many other separate workshops. I trained attendees at the National Association of Court Management Training Conference, All-Rise (National Drug Court Conference) conference, Arizona Drug Court Professionals conference, Arizona Public Defender's Conference, and

MacArthur Foundation Safety and Justice Challenge convenings. I have also provided justicerelated training for the National Center for State Courts (held in Maine), Administrative Offices of the Court in New Mexico, Kentucky, and Michigan, Los Angeles County, the state of Virginia, webinars for the National Institute of Corrections, the California Association of Pretrial Services Agencies, the state of Oregon and the Texas Association of Pretrial Services Agencies, among others. As for personal accomplishments, I hold a Bachelor of Arts in Sociology from the University of Arizona, and I hold a master's degree in justice management from the University of Nevada, Reno. For my alma mater, the University of Arizona, I frequently speak to various classes or at seminars to encourage students to consider careers in the pretrial justice field. Much to the surprise of people that know me through pretrial, I do have several non-pretrial personal hobbies and interests, including attending sporting events, spending time with family and friends, and as of late, outdoor activities such as hiking and walking. Thank you for your time in reading my announcement, and I hope to continue to serve all pretrial justice professionals effectively as a member of the NAPSA Board with your continued support. Pretrial justice has been the focus of my entire career, but the main reason I enjoy my work is that I can connect with and work side-by-side with like-minded professionals through the work I have done and plan to do. Bill has been the recipient of numerous awards over the course of his career, including the National Association of Pretrial Services Agencies (NAPSA) John C. Hendricks Pioneer Award, the AO's Program Services Department Zain Award, and is a fivetime recipient of the Director of the Administrative Office Superior Performance certificate. I have been working in the criminal justice field for the past 25 years, the past 10 have been leading Criminal Justice Services (CJS) programs including Pretrial, Probation and collaborating with Adult Problem Solving Courts. CJS Pretrial is celebrating its 50<sup>th</sup> anniversary this year.

I have worked and supported statewide efforts to create evidence informed pretrial services in local jurisdictions, advocate for non-financial release, promote individualized monitoring and removal of barriers that prevent someone from appearing at court hearings. In conjunction with our District Attorney, we established a pre-file intervention program that is designed for pretrial candidates where completion equals no charges filed.

Pretrial reform has made many strides to ensure every person is afforded equal treatment during their involvement with the justice system. However, there are still people jailed that can't afford bail and are paying for pretrial supervision. Together we can continue to make pretrial effective and just for everyone.

I believe continued education to policy makers, community members, and local jurisdictions on pretrial standards and practices, presumption of innocence, and eliminating barriers need to continue if we want a fair and just pretrial.
