

# **NOMINEES FOR THE 2025 NAPSA ELECTION**

NAPSA will open its annual election on October 7, 2025. The election will be conducted electronically and will close October 29, 2025 at 11:59 p.m. CT.

In order to vote, you must be a member in good standing which means, at minimum, you must be a current member of NAPSA. Memberships sometimes lapse accidentally. Please check that your membership is active before voting, to ensure your vote will count.

#### **POSITION DESCRIPTIONS:**

According to the Bylaws, to be elected as an Officer or Director, a candidate must be a member in good standing; prior experience on the Board of Directors is required for the President Elect position, unless otherwise determined by majority vote of the Board.

## **President Elect (Officer)**

• The **President Elect** serves a two-year term (to end December 31, 2027) at which time the individual will become President for a two-year term (to end December 31, 2029), followed by a one-year term as Immediate Past President (to end December 31, 2030). In addition, duties include, but are not limited to, shadowing the President and acting in his/her absence.

## Atlantic Region Director, Northeast Region Director and At Large Director

- **Region Directors** will have duties including, but not limited to, working directly with members in their region and providing regular updates to the Board regarding regional activity. Directors serve a three-year term (to end December 31, 2028).
- At Large Director will have duties including, but not limited to, providing support to Regional Directors and managing projects as requested by the Board. The At Large Director will serve a three-year term (to end December 31, 2028).

      - Must be a practitioner in one of the following jurisdictions: Delaware, Maryland, North Carolina, South Carolina, Virginia, Washington DC, West Virginia
    - Northeast Region Director

 Must be a practitioner in one of the following jurisdictions: Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont

## At Large Director

Practitioner may live in any jurisdiction

Preferred candidate for each position described above will have a minimum of six years' experience in the field of Pretrial Services including leadership, program administration, or community activism and will be a champion of best practices. Must commit to an average of 10-15 hours a month to the Board; travel is required twice a year for Board meetings and participation in monthly Board calls is expected. Specific duties include, but are not limited to:

- Work directly with members in assigned region;
- Provide regular updates to members regarding regional activity;
- Coordinate membership with affiliate states;
- Regularly attend Board meetings and important related meetings;
- Make serious commitment to participate actively in committee work;
- Volunteer for and willingly accept assignments and complete them thoroughly and on time;
- Stay informed about committee matters, prepare for meetings, and review and comment on minutes and reports;
- Build a collegial working relationship that contributes to consensus;
- Be an active participant in annual evaluation and planning efforts; and
- Participate in fund raising for the organization when/where applicable.
