The New Orleans Marriott offers style, substance and unparalleled service. This 4-star hotel is nestled on NOLA's Canal Street, between the French Quarter and the Warehouse District. NAPSA has a block of rooms reserved at the current government per diem rate of \$136, single or double occupancy.
